

IN2WIN PRIVACY POLICY

Last revised: 24/12/2015

1. **Data Privacy** - In2Win Promotions will comply with the “Australian Privacy Principles” contained in the *Privacy Act 1988* (Cth), as amended by the *Privacy Amendment (Enhancing Privacy Protection) Act 2012* (Cth) (“Privacy Amendment Act”).
2. **Personal information** - The kinds of personal information collected and stored by In2Win Promotions includes but is not limited to user names and passwords, names, phone numbers, addresses, e-mail addresses, information related to GPS location, age, gender, and other demographic information (“User Information”).
3. **Storage of personal information** - Personal information collected by In2Win Promotions will be stored on secure servers and secure backup servers hosted in the Mnet cloud. Data stored in the Mnet cloud is stored and maintained in accordance with Australian Privacy Laws.'
4. **User preferences** - As an Application User, Users will periodically receive information regarding Services provided by In2Win Promotions and Competitions provided by Promoters. If the User wish to change his or her contact preferences at any time, the User can update their Profile Information.
5. **Usage of personal information** - The personal information that In2Win Promotions collects, which is collected on its own behalf, and on behalf of Promoters, is used for the purposes set out in the Terms, as well as to otherwise communicate with the User in relation to Services from In2Win Promotions and offers from Promoters, to provide Services and entry to Competitions, and for any of the purposes set out in the Privacy Policy.
6. **Disclosure of personal information** - By agreeing to these Terms and Privacy Policy, the User agrees that his or her personal information will be disclosed to, captured by, used by, and become the property of In2Win Promotions under the Terms and the Privacy Policy.

In2Win Promotions may use and disclose User’s personal information for direct marketing purposes, unless the User opts out (which can be done at any time in accordance with the Privacy Policy).

Further, and as required, In2Win Promotions may disclose User’s personal information to other parties, including Promoters, who are located and conduct business within Australia.

7. **Sharing of information** - As set out above, In2Win Promotions has partnered with Promoters to enable the User’s entry into the Promoters prize giveaways and Competitions and as part of this arrangement personal information obtained from Users is collected on behalf of, and may be shared with, Promoters. By agreeing to the Terms Users give their consent to the disclosure of their personal information by In2Win Promotions to Promoters

and to the Promoter's use of User's personal information in accordance with their own privacy policy, including to possibly contact the User and inform him or her about offers and updates from the Promoter.

The User acknowledges and accepts as part of the Terms that is their personal responsibility to read and accept the Promoter's separate Privacy Policy, as appropriate.

8. **Cookies** - In2Win Promotions may use third parties to provide parts of the Services as well as to provide analytical data about the use of the Application, Services, and Competitions. In2Win Promotions may deploy devices such as cookies that enable those third parties to anonymously collect and aggregate usage data and report it back to In2Win Promotions. Subject to this Privacy Policy and the Terms, third parties that In2Win Promotions contracts with to help provide Services cannot use the User's personal information for their own purposes without the User's express consent.
9. **Resolving complaints and disputes** - Users wishing to access and correct their personal information, or complain about a breach of their privacy, should contact In2Win Promotions via the contact details below.

In2Win Promotions will aim to respond to all requests for access, corrections, and complaints within 5 business days. Should the User's request require additional input or handling, this will be communicated to the User along with a more appropriate timeframe to deal with the request.

Should the User not be reasonably satisfied with the handling of their request, the User may seek external handling of the matter, as per the Australian Privacy Principles.

Should the User's request be best handled by the Promoter, the User will be directed to the relevant Privacy Officer within the relevant Promoter organization.
